The undersigned, who were appointed by you as a Delimitation Commission under the provisions of Regulation 9 of the National Assembly (Franchise and Registration of Electors) Regulations, 1964, have the honour to present the following report:-

- 1. In pursuance of decisions come to at the Basutoland Constitutional Conference held in London in May, 1964, the Basutoland (Electoral Provisions) Order-in-Council, 1964, authorised the Resident Commissioner to make provision by regulation for, interalia, the division of Basutoland into sixty constituencies for the purpose of the election of sixty members of the National Assembly on the basis of universal adult suffrage.
- 2. The National Assembly Regulations promulgated in terms of the Order-in-Council, after making provision for the appointment of a Delimitation Commission to effect this division into constituencies, direct that the electoral quotas of the constituencies are to be as nearly equal as appears to the Commission to be reasonably practicable. The Commission may however depart from this principle in order to take account of: -
 - (a) The density of population, and in particular the need to ensure adequate representation of sparsely populated areas;
 - (b) The means of communication;

- (c) Community of interest;
- (d) Geographical features; and
- (e) The boundaries of existing administrative areas.

The electoral quota for any consituency is however not to exceed or fall short of the national electoral quota by more than ten per cent. If the Commission considers it impracticable to delimit the constituencies withouth exceeding such variation it must make an interim report on the subject to the Resident Commissioner. The electoral quota for a constituency is to be arrived at by estimating the number of the population of Basutoland who are of or above the age of twenty-one years, and dividing it by sixty.

- While steps were being taken for the appointment of this Commission for the purpose of the necessary delimitation of constituencies the Basutoland Government established machinery for the compilation of lists of persons qualified for the vote under the new constitution; that is, persons of both sexes of and above the age of twenty-one years. These are the "Pitso Lists" referred to in Regulation 8 of the National Assembly Regulations. Assistant Registration Officers were appointed to carry out this work in co-operation with the chiefs in the various districts. In order to assist the Commission by ascertaining as nearly as possible not merely the adults entitled to vote but the whole adult population, these officers were instructed to record, in addition, the names and number of adults disqualified from voting under the provisions of the Proclamation. They were also to record the names of persons qualified to vote but absent from Basutoland. This machinery was set in motion within a few days of the first meeting of the Commissions.
- 14. The Commission met for the first time on the 30th July,
 1964. Immediately after this meeting it issued in the Gazette

and the Press an invitation to the public to send in written representations on any question relating to the delimitation, and to state whether or not a hearing in Maseru was desired. A number of replies to this invitation were received from political parties and individual persons. So far as the Commission has been able to ascertain there are four political parties. Deputations were received at an early stage from three of these, the fourth party having failed to keep an appointment which had been made for it. Deputations representing the College of Chiefs and a group of members of the Legislative Council were also heard. In addition the Commission received a few persons who desired to present their individual views.

- 5. Shortly after it began its labours the Commission let it be known that it proposed to draw up a provisional scheme of delimitation, and having done so to visit the various administrative centres in turn in order to give to all persons concerned an opportunity of stating their views upon the Commission's proposals. This procedure was carried out. A provisional scheme was issued to the districts during November 1964, and meetings open to the public were held in the various districts between the lst and 14th December. Some of these meetings drew very large audiences. They were productive of useful suggestions which the Commission was able to adopt, but there were a number which the Commission was unable to follow consistently with its terms of reference.
- 6. The Commission considered at an early stage the degree of importance to be attached to the various factors, set out in paragraph (2) of this Report, which were to be taken into account in order to justify departure from the principle of equality of adult population.

The Regulations made it clear that in the absence of an amendment the Commission had no discretion to exceed the permissible variation of ten per cent above or below the quota. This imposed a very narrow limit upon the allowance which might be made for the different factors of variation, and it was no doubt a realisation of that fact which was responsible for the provision enabling the Commission to make an interim report to the Resident Commissioner should it find that the restriction was impracticable. The Commission has not, however, found it necessary to make an interim report on this point.

The most important of the permissible factors appeared to be "(b) the means of communication" and "(c) Geographical features", which are so closely interrelated that they may conveniently be considered together. By far the greater part of the area of Basutoland consists of high mountain ranges intersected by deep valleys, many of which contain rivers which in the rainy season become rushing torrents and may be impassable for two or three weeks at a time; and a flood period might conceivably occur at the time of an election. In many cases the only means of crossing the mountain ranges is by bridle path. Roads and bridges are few, and the roads, where they exist, are often usable only by the "jeep" type of vehicle. The presence of mountain ranges and rivers has therefore an important bearing not only upon the siting of boundaries between constituencies, but also upon the allocation of adult population to the constituencies, since a strict adherence to the principle of equality might result in an artificial boundary, making it difficult or inconvenient for a section of the voters to get to the polls. These conditions obtain more especially in the mountain areas, and do not apply in the same degree to the remaining extent of the country, consisting of the lowlands and the foothills.

- 8. Differences in density of population (factor (a)) are also of importance, and are related to the factors just discussed. The mountain areas are the least, and the lowland areas the most densely populated areas. The least densely populated district in 1956 was that of Mckhotlong, in the mountains, with a density of 25 to the square mile, and the most densely populated Berea, in regard to population a predominently lowland and foothil district, with a density of 88. Density of population in the mountains did not appear to be of great importance as affecting the ability of voters to cast their votes, since this would depend upon the number and placing of polling stations; but it would have a bearing upon the ability of members of the National Assembly and of candidates for election to cover their areas at and between elections.
- 9. The question of community of interest (factor (d)) did not appear to the Commission to be of great importance; almost the whole African population of Basutoland was in 1956, and is today, a rural population. The Commission was informed that the mountain population was mainly dependent upon livestock, while the lowland population relied principally upon agriculture, but in the circumstances prevailing in Basutoland there is no important diversity of interest between the mainly agricultural and the mainly pastoral sections of the population. There is no division, such as is to be found in the Republic of South Africa, into a farming population on the one hand and an industrial, mining or commercial community on the other.
- 10. A certain degree of urbanisation has developed round some of the administrative centres, such for example as Maseru, but this is comparatively unimportant at its present stage, and the Commission has had it in mind when dealing with these localities.

11. A population said to be between 2,000 and 3,000 persons has sprung up at the Letsie-le-Draai diamond diggings in the Mokhotlong district, but the Commission was informed that this was not a settled population, as it consisted mainly of men who lived in adjoining areas and would vote in their home villages.

12. Some community of interest, however, is afforded by tribal affiliations, and the Commission has endeavoured to regard tribal sentiment as far as possible.

13. The remaining factor to be considered is (e), the geographical boundaries of the existing administrative areas. At one of the public meetings held in order to discuss the provisional scheme, it was contended that the Commission had exceeded its terms of reference wherever it had combined portion of one administrative district with portion of an adjoining district, because this involved the elimination of the district boundary in that constituency. It is clear however from the wording of Regulation 10 (3) of the National Assembly Regulations that the Commission has discretion to do this, and that the location of existing district boundaries is in no different position from the other factors of variation which the Commission has to take into account.

the demarcation of boundaries should be based upon the principle of numerical equality, but also that the voters in each constituency should have convenient facilities for voting. These considerations should have precedence, within reason, over questions of administrative convenience, and the Commission has in some cases found it impossible to preserve district boundaries and at the same time to keep within the permissible numerical limits, or to give due regard to community of interest and convenience of communication.

A typical example of this type of difficulty arose in regard to the District Council Electoral Division of Motete, in the district of Butha Buthe. Owing to the existence of high mountain ranges this Division has no convenienct means of communication with its administrative centre, Buthe Butha, and the Commission was informed that residents in the divisional area were obliged to make a detour through the Leribe district in order to reach Butha Buthe. The Commission therefore decided to combine this area with an area in Leribe district, and the constituency of Malibamatso (No. 5) is the result. Similarly community of interest and proximity suggested the inclusion in the Maseru constituency of Sebaboleng, a semi-urban settlement, which, though situated in the district of Berea, lies only 2.8 miles from Maseru. 15. It became apparent very soon after the Commission began its deliberations that difficulties would arise in estimating the adult population of Basutoland with a view to the fixing of the national electoral quota. Regulation 10 (4) of the National Assembly Regulations provides that in calculating the estimated number of the population who are of or above the age of twenty-one years the Commission may refer to the latest census of the population and such other statistical advice and evidence as is available. The most recent census took place in 1956, and though this reveals the total population in that year the census tables do not divide the Basuto population into adults and non-adults.

16. It was not practicable to attempt to remedy this lack of information by examination of the field records collected for the purpose of the census. The Commission had therefore to consider whether it was possible, from other statistical evidence, to estimate the number of the adult population 1956, in order, having done so, to use such an estimate as a basis from which to calculate the probable adult population at the

present day.

17. In 1960 a Social Survey based upon the Census was carried out by Professor Batson of the University of Cape Town, and in the same year an Agricultural Population Survey was carried out by the Government statistician, Mr. Morojele.

The Commission considered the possibility of using the material employed in these two surveys in order to arrive at a reasonably accurate estimate of the present day adult population. In each case however, the survey had been made on the sampling system, the information relating to a comparatively small number of families having been examined. For that reason and for others which it does not appear necessary to elaborate, it seemed doubtful whether this would provide a satisfactory basis for the delimitation.

18. The Commission also considered the possibility of using the information contained in the Voters' Rolls which were compiled for the purpose of election of members of the District Councils established by Proclamation No. 52 of 1959. This proved impracticable in view of the fact that very few women were entitled to vote at the District Council elections, the payment of tax being one of the qualifications for the vote, and there being very few women tax-payers. The Voters' Rolls therefore afforded no guidance as to the number of adults in Basutoland or in any of its districts or electoral divisions. 19. Apart from the difficulty of computing the present adult population from these materials, there was a further complication that such a computation would take no account of shifts of population and in particular of certain abnormal increases in the population of some of the districts which had come to the knowledge of the Commission and which would cause difficulties in adhering to the principle of equality in the electoral quotas.

- 20. As the delimitation was to pave the way for the first election to be held under the new Constitution, and as, according to the information given to the Commission, there was a fairly even balance of contending political parties, the Commission felt that it was important to aim at the greatest possible degree of accuracy in the data which were to be used as the foundation of the delimitation. It therefore considered the desirability of basing its estimate of the adult population upon the Pitso Lists referred to in paragraph 3 above, which, if the registration were efficiently conducted throughout, could be expected to give an accurate picture of the position at the present time.
- 21. The matter was however complicated by a further difficulty. The Constitutional Commission which had been appointed in Basutoland in 1962 presented a report suggesting that the date of independence for Basutoland should be fixed at one year after the first elections to be held under the new constitution, on the understanding that these would be held before the end of 1964. At the Constitutional Conference held in London in 1964 it was agreed that every effort would be made to ensure that the first elections would be held before the end of 1964.
- 22. It was fairly obvious that if the Commission had to wait for the Pitso Lists in order to fix the electoral quota, it would be highly improbable that the election could be held before the end of the year as planned.
- 23. The Commission discussed with the various deputations which came to interview it the difficulties which were likely to be encountered in ascertaining the adult population, and the desirability or otherwise of waiting for the Pitso Lists for the sake of accuracy in the determination of the quota. It was pointed out that if this course was adopted, it would be difficult to ensure that the first election would take

place before the end of the year. All the parties and individuals with whom the question was discussed expressed. the view that in the interests of accuracy it was desirable to wait for the Pitso Lists. With the exception of one of the political parties all agreed that accuracy in the determination of the quota was more important than the date of the election. After careful consideration the Commission came to the conclusion that it was advisable to wait for the Pitso Lists before setting to work on the drawing of boundaries. 24. There are, unfortunately, difficulties in the way of an accurate enumeration of population in Basutoland, owing mainly to the comparative inaccessibility of certain areas, and the absence at work in the Republic of an abnormally large proportion of the male population. In view of these difficulties, it was considered advisable to use the period of waiting for the Pitso Lists in ascertaining as far as possible, by computation from the census material and other information, what the adult population, both in the country and in the several districts, should be at the present day. Information so obtained would be valuable as a check on the accuracy of the Pitso Lists when received. 25. In this aspect of its inquiry the Commission has received most valuable assistance from the Government statistician. By analysis of the Census material the statistician was able to furnish the Commission with the population figures for each Headman's area or "village" throughout Basutoland, and by process of computation the probable adult population of Basutoland and of its several districts as on the 31st December, 1964.

26. On the statistician's computation, the total adult Basuto population on that date should be 444,621. To this figure must be added the probable adult non-Basuto population on the

same/....

(Owing to recalculation this figure differs slightly from that which was given in the provisional scheme of delimitation).

27. It had been expected that the Pitso Lists would be available by the end of the first week of October, but it was the end of that month before they all came to hand. It was then found that they could not be relied upon to furnish an accurate or even approximately accurate record of the total number of persons entitled to vote. This was due to various causes: the great difficulty of ascertaining the number of absentees employed on long- or short-term contracts in the Republic; political apathy among the population in certain districts; in a few cases want of co-operation by some of the chiefs; and in general, difficulty of accurate enumeration in the more remote and mountainous areas.

28. It was therefore impossible to use the Lists as material from which to calculate the national electoral quota. This was a great disappointment to the Commission, and caused the loss of a certain amount of valuable time. The Lists did however afford valuable information pointing to certain shifts or abnormal growths of the population in certain areas in the postcensus years. It was found for example that in some Headman's areas the number of applications for registration on the voters' roll exceeded the estimated adult population as computed from the census returns. This was the case at Maseru and some other of the lowland localities. This information has been embodied in the Commission's scheme of delimitation. The Pitso Lists also enabled the Commission to bring the lists of villages up to date.

29. The Pitso Lists having proved unreliable as a guide to the total adult population, the Commission was thrown back upon the figures supplied to it by the Government statistician. Adopting the figure 452,135 as the estimated adult population of

Basutoland/.....

Basutoland at the present day, the national electoral quota was found to be 7,536; the permitted variation of ten percent allowed a maximum number of voters in any constituency of 8,290 and a minimum of 6,782. These figures have been adopted by the Commission in framing the delimitation.

- 30. The Commission wishes to point out however that the process of computation which yielded these figures was based upon a probable rate of increase of population, and also upon a probable ratio of adults to total population. There was no great degree of certainty that the rate of increase and the ratio referred to were precise. Moreover there is some doubt whether the census figures are entirely reliable, the Government statistician having expressed the opinion, in one of his reports to the Commission, that the census figures were an under-estimate of the population. The figures which the Commission has been obliged to accept can therefore only be regarded as approximate, it being necessary to adopt them in default of precise or recent statistics.
- 31. The method adopted in the delimitation of Electoral Divisions under the District Councils Elections Proclamation No. 53 of 1959 was to schedule the Headman's areas or "villages" which were to fall into each electoral division. The Commision considered whether it should follow this system or the normal method of delimitation by boundaries marked on maps with written descriptions of the boundaries. Only two maps of Basutoland were available for the latter purpose if adopted.
 - (i) A 1/250,000 map, the scale of which is too small for accurate delineation and which is moreover inaccurate in important respects.
 - (ii) A1/50,000 map in separate sheets, of which about 60 would be required to cover the whole area of Basutoland.

The latter was considered too unwieldly for the purpose; and moreover though accurate in its representation of physical features these are insufficiently named, which would make the verbal description of boundaries extremely difficult. Enquiries were made as to the possibility of reducing the scale of this map so as to make it more suitable for the purpose, but the delay and the expense involved ruled this out. The Commission therefore decided to follow the method adopted for the purpose of the District Council Electoral Divisions, as it is empowered to do by Regulation 10 (5) of the Regulations.

32. The Electoral Divisions defined in Government Notices 24 and 28 of 1959, made under Section 8 of the District Councils Elections Proclamation, set out the names of the "villages" or areas which are to be included in each electoral division, and the Commission has used these as the basis for its delimitation. In the case of each constituency, therefore, the Appendix which we annex to this report sets out the villages at present included in the constituency concerned, as well as a number of villages, not included in the schedules of 1959, the existence of which has come to the knowledge of the Commission through the Pitso Lists or other sources of information. This method was explained at the various public meetings arranged by the Commission for consideration of its provisional scheme. It was easily understood by the members of the public who were present, it evoked no adverse criticism, and it appeared to be generally acceptable. In the case of each constituency there is, in addition to the list of villages, a written description of the boundaries of the constituency. The list of constituencies, so described, is contained in the First Appendix to this report.

33. The selection of names for the constituencies caused the Commission some little difficulty. It was obviously desirable not to use the name of any existing District Council

Electoral/.....

Electoral Division, and the use of the personal names of Chiefs was thought to be likely to cause confusion. The choice of names was therefore somewhat restricted. At all of the public meetings the Commission's difficulty in selecting appropriate names was pointed out, and suggestions for alternative names were invited. In several instances this led to changes in the names originally proposed. Apart from these changes, the names originally allocated appeared to be generally approved. 34. With the assistance of the Government Surveyor the Commission has had the boundaries of the different constituencies delineated upon plastic-backed copies of the 1/50,000 maps referred to above. A list of these maps is contained in the Second Appendix to this report. The maps will be signed for purpose of identification by the Chairman or a member of the Commission and will be deposited for safe custody with the Chief Secretary. These maps will be available for reference in the event of any disputes as to the precise location of the boundary of any constituency. We have made it clear however in the introductory notes to the schedule of constituencies that in case of any inconsistancy between the list of villages and the maps, the list of villages is to prevail. village or area does not fall within any of the villages or areas listed, it will form part of the constituency within which it lies according to the map.

- 35. For ease of reference the Commission annexes to this report in Appendix III a sketch map on the 1/250,000 scale which shows the various constituency boundaries. But the intention of the Commission is that the Plastic-backed 1/50,000 maps referred to in paragraph 34 above shall be the ultimate authority in case of any dispute.
- 36. The Commission desires to bring to the notice of the Administration that at all the public meetings held by the

Commission speakers referred to the difficulties encountered or likely to be encountered by persons living in the more remote localities in casting their votes. It seemed to be the general impression that all the voters in any constituency would have to record their votes at the same place, and speakers were only reassured when it was pointed out to them that there might be several polling stations in a constituency and that it was for the Government to establish polling stations where necessary. In the mountain areas the normal mode of travelling is on horseback, and distances which are apparently short on the map may involve several hours' riding over steep ridges and through deep valleys. Moreover horseback is not the normal method of travel for women in Basutoland and it is inconvenient for the aged. Unless an adequate number of polling stations is provided, more especially in the mountain areas, voters may be disinclined to go to the polls and an unrepresentative election may result. The Commission therefore wishes to stress the importance of an adequate number of polling stations, more particularly in the mountainous areas.

37. The Commission wishes to record its thanks to all those who have assisted it in the performance of its task, and particularly to Mr. P. B. Sanders, the Chief Electoral Officer; to Mr. C.M.H. Morojele, the Government Statistician; to Mr. R.N.T. Phillips, the Government Surveyor, for his preparation of the numerous maps required by the Commission and the written descriptions of the boundaries of constituencies; to the District Commissioners and their staffs

in all districts, for their co-operation generally and in the arrangements for the holding of public meetings, to Mrs. Sanders for her assistance in the preparation of the district maps upon which the Commission based its work, and to Mr. Gary Davis for the very able performance of his duties as Secretary to the Commission.

APPENDIX 1

Constituencies delimited by the Commission, together with descriptions of the Constituency boundaries:

INTRODUCTORY NOTES

- The Electoral Divisions referred to in the descriptions are the District Council Electoral Divisions, under Section 8 of the District Councils Elections Proclamation, which are described in the Annexure to Government Notices Nos. 24 and 28 of 1959, as amended by Government Notice No. 32 of 1959, and printed on pages 275 to300 (inclusive) of the Laws of Basutoland, 1960, Volume 1.
- District roundaries, where referred to, are those at present recognized for administrative purposes, and in the event of dispute are, for consituency purposes, to be taken as delineated in the 1/50,000 maps referred to in the Report.
- Should there be any inconsistency between the list of villages or areas in any constituency and the boundary of the consituency as delineated in the said maps, or one of them, the list of villages or areas will prevail.
- If any village or area does not fall within any of the areas or villages listed it will form part of the constituency within which it lies according to the said maps.

BOUNDARY:

Starting on the Caledon River Border where the stream that flows to the east of Makabanna's village joins the Caledon, the boundary follows the border west and south west to the top of the kloof on the

escarpment 3 miles to the east of Namahali Police Post, where the Eland River rises; thence south along the Butha Buthe - Mokhotlong district boundary. (which runs along the watershed between the Matseng and Kholtselo river catchment areas; thence along the Butha Buthe - Leribe district boundary to the point where the district boundary crosses the Motete River; thence north east along the Mokhotlong - Libono bridle path past Mahlasela Hill; down the Fana stream to the confluence with the Tlolohatse river; thence down the Tlolohatse to the confluence with the Tsehlanyane river; thence up the Tsehlanyane for 12 miles; thence north east for 1 mile to the common point for Nos. 1, 3 and 5 constituencies; thence due east for ½ mile to the source of the Moteng stream; thence north west along the Ox-Bow access track for 1 mile before following a small tributary of the Tsehlanyane north east to the source of the Khatiba stream which is a common point for Nos. 1, 2 and 3 constituencies; thence along the Khatibe stream to a point a 4 mile above its junction with the Nqoajane stream below the village of Hlakametsa; thence in a northerly direction along the ridge to the west of Nqoajane stream for 21 miles before joining the Nqoajane 3 mile west of Topi village, thence up the stream to a point 4 mile west of Topi village; thence north north east following a ridge between two streams to the top of the Qholaqhoe watershed between the Nquajane and Caledon catchment areas; thence west across the ridge to join the headwaters of the stream that flows to the east of Thakabanna village and thence north west down the stream to its starting point.

2. HOLOLO
